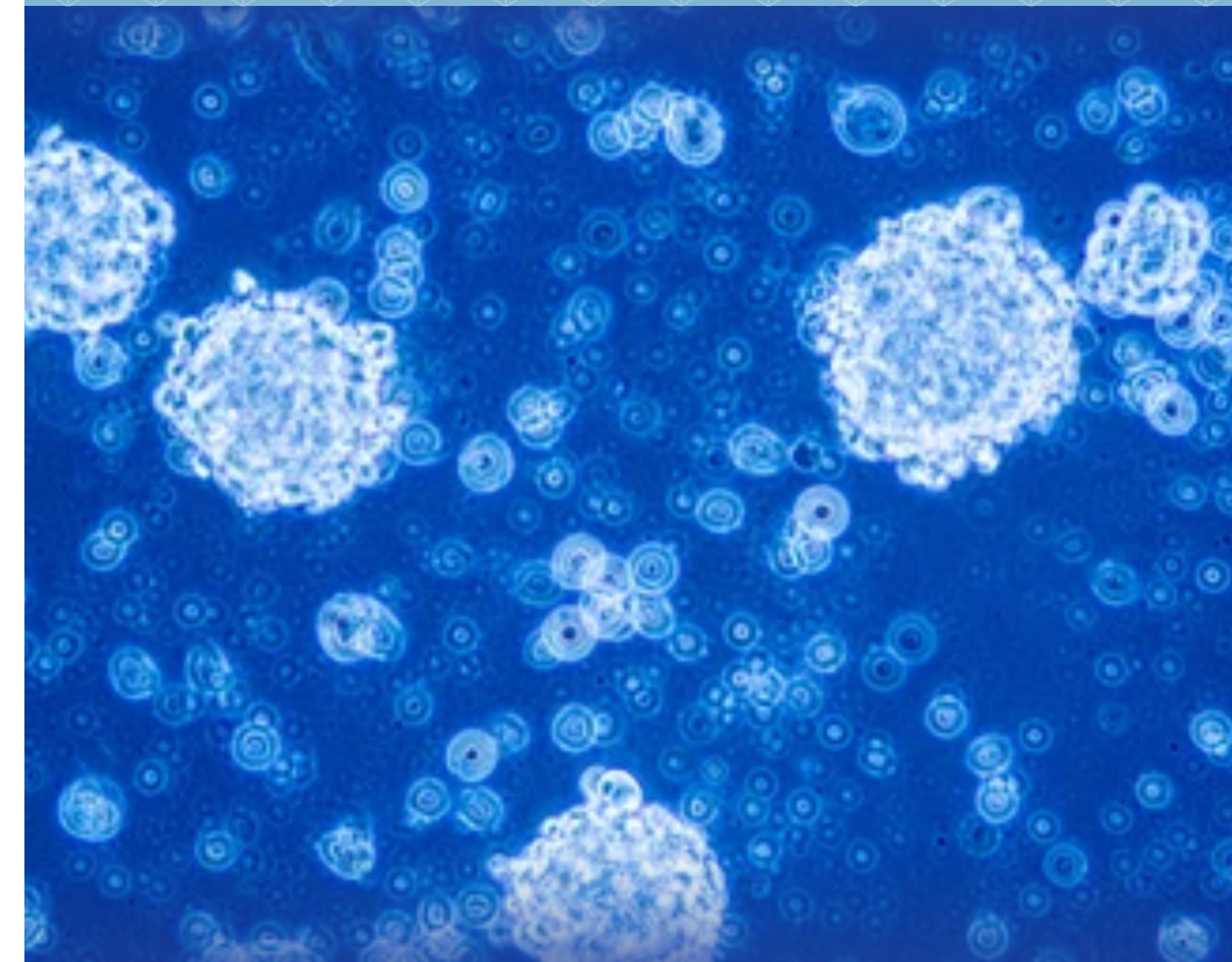

LEARNING OBJECTIVES

Upon completion of this activity, participants should be able to:

- Identify updates in the treatment of cervical, endometrial, and uterine cancer.
- Understand pelvic radiotherapy and appropriate treatment options.
- Identify physical therapy interventions for urinary incontinence, pelvic floor pain, prolapse, and retention.
- Identify proper post op care for the patient undergoing breast cancer surgery.
- Define stages of lymphedema, causes and implications for the cancer population; identify the most common complications of lymphedema and define Complete Decongestive Therapy.
- Apply up-to-date surveillance and diagnostic strategies among at risk individuals; identify patients with HCC who are eligible for curative surgical therapies; understand recent advances in systemic therapies, including introduction of immune checkpoint inhibitors.
- Understand the role opioids play in pain management and potential shortcomings.
- Differentiate between palliative and hospice care and when to refer for each service.
